OFFICIAL MEMORANDUM

It is hereby informed that Karnataka PGET 2014 for Postgraduate Medical and Dental Degree and Diploma subjects is being conducted by National Board of Examination, New Delhi. Applications has to be submitted online by all the Autonomous in-service doctors who are willing to take up the examination between 10th to 31st January 2014. The detailed information bulletin is available at website. www.nbe.gov.in/pget for medical degree and diploma and www.nbe.gov.in/pgetdental for Dental degree and diploma.

However a hard copy of their online application form along with attested copies of all necessary documents should be submitted by the Autonomous In-service Candidates by RPAD to the Director of the concerned Autonomous Institute failing which their candidature for the examination will not be considered. The Director of the concerned Autonomous Institute shall scrutinize the applications especially with regards to eligibility criteria.

No in-service candidate shall be eligible for admission under these rules:-

a) Unless he/she has put in not less than Five years of regular employment in service including successful completion of probation period as on **31st of March 2014**.

b) An in-service candidate who is already holding a Post Graduate Degree in any Specialty shall not be eligible for admission to any other Post Graduate Degree or Diploma.

c) An in-service candidate who is studying in any Post-Graduate Degree or Diploma course shall not be eligible for admission under these rules.

d) An In-Service candidate who is already holding a Postgraduate Diploma in any specialty shall be eligible for Post Graduate degree course in the same Specialty and shall not be eligible for any other Post Graduate Degree or Diploma Courses.

e) Incomplete and incorrect applications are liable for rejection. No changes will be entertained after the submission of application.

f) No In- Service Candidates are eligible; if they have any Departmental enquires against them.

g) The Government In- Service Candidates should produce a declaration as given below along with the application form.

"I solemnly and sincerely affirm that the information furnished by me in this form are true and correct and in case of any of the information furnished by me is found to be false at any point of time, I am liable for the criminal prosecution including forfeiture of seat. I will also abide by the service bond that is given by me at the time of acceptance of seat selection."

Directors of Autonomous Institutions should email the scanned and duly signed list of eligible candidates to Director of Medical Education by 02-02-2014 as also display the list of eligible and ineligible candidates on their respective websites for the benefit of all the concerned candidates.

It is the responsibility of Directors of Autonomous Institutions to ensure that the applications submitted by the candidate which are forwarded to the Directorate of Medical Education shall fulfill all the eligibility criteria required for taking up the examinations. Only such applications which fulfill the eligibility criteria should be forwarded to the Directorate of Medical Education. Action as per KCSR (CCA) Rules will be initiated in case of any ineligible applications against all concerned.

The Director of Medical Education will consolidate the list received from all the Autonomous Institutions and this list of eligible candidates from all the Autonomous Institutions as furnished by the Directors of the concerned Autonomous Institutions will be forwarded to NBE for activation of hall tickets. The consolidated list of eligible candidates from all the Autonomous Institutions which has been forwarded to NBE will be displayed in the website of Director of Medical Education for information to the candidates.

As practiced in the previous year, this year also, interse merit of Autonomous Institute candidates who have qualified in the entrance examination will be determined by the marks scored in the entrance examination without giving any service weightage.

This information shall be put up in the notice board and the website of all the Autonomous Institutions for information to candidates who are willing to participate in PGET 2014 exams.

h) An In-service candidate applying under In-service quota is not eligible to select a seat under Non In-service quota. Likewise, a candidate applying under Non In-service Quota will not be eligible to select a seat under In-service quota.

In addition to the above following also needs to be verified by the Directors of the Autonomous Institutions.

| i) Appointment order | - verify whether the candidate has completed 05 years of regular service including successful completion of probation period and is less than 45 years of age as on the day of admission to Post Graduate Course. If the candidate is not fulfilling this criteria application should be rejected. |
| ii) Probationary period declaration. | - verify whether all the departmental examination has been passed and probationary period has been declared. |
| iii) KMC registration certificate. | - If, a particular candidate has PG Diploma in a subject, he / she shall apply only for PG Degree in the same subject. |
| iv) Departmental Enquiry | - Whether any departmental enquiry is pending. If the departmental enquiry is proceeding, then the candidate's application shall be rejected. |
| v) Confidential report | - Review 05 years confidential report. |
| vi) MBBS marks cards | - Scrutinize the marks entered by the candidates in the application form with the original MBBS marks cards. |
| vii) Attempt Certificates | - Ensure the number of attempts written by the candidates is correct by verifying the original marks cards. |
| viii) Degree Certificate | - Scrutinize the Degree Certificate. |

The list of eligible candidates shall be sent to the Director of Medical Education for onward transmission to National Board of Examination for activation of hall tickets for In-Service Candidates by 02-02-2014. Mere filing the Online Application Form will not entail any eligibility to the In-Service candidate to appear for the examination as necessarily hard copy of the application has to be submitted to the respective Director of the concerned Autonomous Institute who will scrutinize and intimate eligibility of the applicant to appear for the examination to the director of Medical Education. The Director of the concerned Autonomous Institute shall also display the list of the eligible candidates that has been sent to the Directorate of Medical Education on their respective department websites for the information of all concerned candidates. The list of ineligible candidates and the reasons for ineligibility shall also be displayed on the website.

In addition to the above, In-service doctors should furnish the information sought in the application form and the Directors of the Autonomous Institutes should verify and forward the applications to The Executive Director, Karnataka Examination Authority, Malleshwaram 18th cross, Bangalore (for verification of documents).
